**Freehold:** Sheriff Shaun Golden was the proud host of the Monmouth County Law Enforcement 'Show of Strength' ceremony, held on April 22, in conjunction with the Department of Defense's Employer of the Guard and Reserve, (ESGR) and the New Jersey Parole Board.

The event, which was attended by more than 100 people and included law enforcement officials and members of the military throughout Monmouth County, recognized the show of support law enforcement provides to its citizen soldiers, when the nation calls on them to defend our country.

ESGR coordinates these events throughout New Jersey and works with employers in an effort to support and value the military service of its employees and to ensure that reservists and National Guard members can return to their jobs from active duty.

While performing military service, Monmouth County employees receive full pay for 90 days, and, after that time, they receive the difference in pay between the employee's regular earnings and the military base pay for active duty. Families continue to maintain health benefits, and the Monmouth County Sheriff's Office actively supports families who have to endure the hardships when their loved ones are away.

During the ceremony, Sheriff Shaun Golden, whose agency currently has 21 active members of the military, Acting Monmouth County Prosecutor Christopher Gramiccioni, who recently served on active duty in the U.S. Navy as a lieutenant commander, Freeholder Lillian G. Burry, who has been active with the transition of Fort Monmouth and an advocate for active duty military members and veterans and Michael Ruane, Director of the Monmouth County Office on Aging, Disabilities and Veterans Services, were all presented with the Employer Support of the Guard and Reserve's (ESGR) prestigious *Seven Seals Award*. All of the recipients have demonstrated outstanding support, commitment and patriotism to the United States military and their efforts have carried out ESGR's mission.

"Our armed forces are critical to our nation's defense and therefore it's critical we support all of them for the heroic efforts in keeping our country safe," said Acting Prosecutor Christopher Gramiccioni.
