Community Action Number - Matawan #4

Matawan Municipal Community Center Generator (HMGP-FEMA -DR-4086-NJ-366-R) Purchase and install a full building back-up generator to serve the Matawan Municipal Community center/Matawan Borough Hall. Total project cost of \$166,473.00. RFP was awarded on October 6, 2015 (Resolution # 15-10-11). Projected completed 2016.

Community Action Number - Matawan #1

Replacement of the Lake Lefferts Dam (High Hazard Dam) Project is a joint project between the Borough and Monmouth County. Project is currently in the design phase and was recently submitted for NJDOT grant funding.

Replacement of the Lake Matawan Dam (High Hazard Dam) Project is a joint project between the Borough and Monmouth County. RFP has been issued for engineering.

Elevation of Aberdeen Rd. Project was initially proposed to alleviate interrupted emergency response caused by flooding but has since been looked upon to serve as a detour route for the Lake Lefferts Dam project. Elevation of road necessary prior to Lake Lefferts project

The Borough will be issuing a RFP for the purchase and installation of a full building back-up generator at Matawan Police Headquarters. Initial estimated cost is \$129,484.00 The project is expected to be funded through

the Monmouth County Improvement Authority (MCIA) and the 2017 Municipal Budget.
