#### MONMOUTH COUNTY SHERIFF'S OFFICE REINFORCES PROJECT MEDICINE DROP TO HELP COMBAT DRUG ABUSE

February marked three years since the Monmouth County Sheriff's Office joined the New Jersey Attorney General's "Project Medicine Drop" and I'm pleased to announce it's been highly successful. The medicine drop box located at the Monmouth County Sheriff's Office along with two mobile drop boxes which are transported to senior centers, in an effort to provide even greater community outreach to residents, has



collected and disposed of hundreds of pounds of prescription drugs that may have ended up in the wrong hands.

This partnership was another major step in the ongoing fight against heroin and opiate abuse and remains a principal concern and huge commitment of law enforcement.

In 2019, according to the most recent statistics, there were 124 overdose deaths in Monmouth County. The Monmouth County Sheriff's Office and the Monmouth County Prosecutor's Office are both leaders in this ongoing fight, but can't do it alone. That's why it's important to once again

remind the public to assist, by cleaning out their medicine cabinets, where addiction starts for many, since opiate and heroin use are often fueled by prescription drug abuse.

Project Medicine Drop Box, where you can dispose of unwanted, unused and expired medicine from your homes, is vital. The permanent collection site is located at the front entrance to the Monmouth County Sheriff's Office, at 2500 Kozloski Rd. in Freehold which residents can utilize at any time, all year long. Project Medicine Drop

is the most beneficial program where the community and law enforcement work together to help combat this epidemic and reduce the amount of prescription drugs that are readily available.

We are aware that residents, particularly seniors, may find it inconvenient to travel to the sheriff's office and dispose of their medications. In addition, the mobile "Project Medicine Drop" provides much needed accessibility by visiting senior and recreation centers in communities throughout Monmouth County.

The effort doesn't stop there. The many programs and services such as our HOPE One, truck which makes its way around Monmouth County, is also an essential asset in the fight against drug



abuse. HOPE One, launched in 2018, travels into the communities to offer services and programs to individuals and or family members with substance use disorder. This great approach adds another resource, and through all these program, we hope to continue to secure a safer and healthier path to sober living.

# MCSO WARNS TO BEWARE OF SCAM



Sheriff Golden sent a warning out in February to be aware that a SCAM is going around across the country. Envelopes below are being sent out nationwide with a cashier's check included, and an offer on how you can make money by sending Walmart Money Orders via Fed Ex, text and email. This is fraudulent, but to make it appear legitimate, the return addresses being chosen are credible. In some instances, Monmouth County Board,

1 East Main Street, Freehold is being used. As a result, the MCSO has been aggressively investigating this scam.

Always use your best judgement regarding any type of scam. If it doesn't seem right, it's probably not. Beware of offers for money/free products, claims you won a contest you did not enter, or get-rich quick schemes and if you feel you have become a victim contact local authorities.

Kindly report to him that the Memo arrived safe and you found the Money (Cashiers Check) to carry outthe survey intact in the envelope.

1) Kindly proceed to make deposit of the check at your Bank Branch upon receipt of your package (immediate funds availability with processing fees apply). The Check must be deposited with your Bank. DO NOT cash check from cashing stores, make sure it is at your Bank you deposit the Check increave have a trace and will make sure the right person processes the payment the TEXT KLEPPS IMMEDIATELY AFTER THE DEPOSIT HAS BEEN MADE FOR FUNDS AVAILABILITY TIME, SO HE CAN RECORD.

2) The funds will be available a few hours or the next business day. Soon as the cash is made available by your Bank Branch, you will withdraw the cash and take CASH ONLY with you to the nearest WALMART STORE AND PURCHASE FOUR PIECES OF WALMART BLANK MONEY ORDERS is \$1000 in four pieces from the same cashier, insist on buying \$1000 on each Money Order in Four (4) pieces which makes it a total of \$4000. Thereafter deduct your commission which is \$700 and an extra \$200 to cover cost of gas/transportation. PLEASE NOTE here that we have received several anonymous reports of **Staff Misconduct Turning Back Customens; Unnecessary Restrictions; Over-Charging and Lapses** at several of the Walmart in and around your 2IP-Code and this is where you come in, kindly maintain absolute calm and evaluate the Point of Purchase, taking into consideration the following:

- -Ambiance/Outlook of the Shop/Outlet

You will make sure ALL FOUR \$1000 MONEY ORDERS purchased are left BLANK, CO NOT write your name on the Money Orders, leave all Four (4) pieces blank and proceed to the nearest FedEx Office and have them sent out with FedEx OVERNIGHT PRIORITY. Make sure you Four (4) pieces blank and proceed to the nearest Fedbx Office and have them sent out with Fedbx OVERNIGHT PRIORITY. Make sure you include the RECEIPT OF PURCHASE for all Money Orders in the envelope you are to mail DO NOT miss putting the receipts of purchase in the FedEx envelope to the address your Batch Supervisor (Kelly Michelle) will provide you. At the Walmart Store, under no circumstance should you acknowledge that you are evaluating their service or a secret should per might ask and giving that up will defeat the purpose of this evaluation program. Your evaluation is being monitored and can become a counter evaluation if you fail to follow any part of the instruction and that is not without consequence, Text Messages are advised as the quickest means to report every step of the way especially on the day of carrying out your task at the Walmart Store. Make sure you keep Receipt of Purchase of the Money Orders and enclose them in the envelope you are to mail from FedEx. Send a Text Message to the Phone Number you have on this Memo. And ALWAYS respond to texts from this Company directly to Ycelly Michelle on the number on this MEMO ONLY which is 300-892-8013 330-892-8013

The Monmouth County Correctional Institution tours included nurses from Georgian Court College and sociology students from Brookdale Community College in February.




