

8.0 PLAN ADOPTION

The Monmouth County HMP was submitted to the New Jersey State Hazard Mitigation Officer on April 15, 2025. It was forwarded to FEMA for final review on July 22, 2025. FEMA granted approval-pending adoption on August 7, 2025. **Full approval from FEMA was received on October 27, 2025, expiring on October 26, 2030.**

Once FEMA granted approval-pending-adoption on August 7, 2025, the Project Team coordinated with Monmouth County and each of the 53 municipalities to adopt a resolution of the Monmouth County HMP. The Project Team provided a resolution template to each municipality to streamline the adoption process. The Resolution Template is included in Appendix B. Adopted resolutions passed by each of the 53 municipalities and participating special districts are located in Appendix E.

Below is Table 8.0-1 which details the adoption date of each municipality, the county, and participating special districts, along with eligibility for funding. This HMP update achieved 100% participation from Monmouth County's 53 jurisdictions.
